1. With reference to G.O. first cited the committee was constituted for fixation of fee in respect of Self-Financing UG / PG Medical Colleges and at present the Committee under the Chairmanship of Hon'ble Mr. Justice R. Pongiappan.
2. The Chairman of the Committee convened a meeting on 21.03.2025 to discuss with regard to fixation of fee for the UG / PG Medical Courses in the Self Financing Medical Colleges. During the meeting the Committee decided to call for the fee proposals from the Self Financing medical colleges offering UG / PG Medical Courses. In this connection, individual mails and letters have been sent to the principals of the colleges on 28.03.2025 vide ref (2) requesting them to submit their fee proposal for revision of fee for the year 2025 -2026 and two subsequent academic years in the prescribed format.
3. The Committee decided to verify the proposals submitted by the colleges in detail and requested Thiru. R. Balachandran, who is the member of this Committee (Chartered Accountant of repute) to verify the details of income and expenditure statements submitted by the colleges and prepare the consolidated expenditure statements. Accordingly the Committee verified the Expenditure Statement submitted by the Medical Colleges, especially in respect to 20 Major heads namely Salaries and allowances including PF (Teaching, Non-Teaching and Administration), Welfare Expenses, Electricity Charges, Telephone, Postage & Internet, Equipment Purchase, Books & Periodicals, Printing & Stationary, Consumable, Research and Development, University affiliation fees and Inspection Charges, Sports, Games, Meetings and Functions, Awards, Merit Scholarship, Travelling and Conveyance,

Repairs and Maintenance, Depreciation, Advertisement and Miscellaneous Expenditure.

Further the Committee requested the colleges to bring the following documents for verification.

1. Salary Acquaintance
  2. TDS certificate (Quarterly return statement)
  3. Audited Income / Expenditure statement along with Income Tax Return.
  4. Supporting documents for the expenditure claimed under the Head / other Expenditure.
4. Later before fixing the fee the Committee decided to invite the suggestion from representatives of The Tamil Nadu Self Financing Medical Colleges Association (TNSFMCA) and thereafter in response to the request send by this Committee, the following representatives of the Associations appeared before the Committee on 12.06.2025 and gave suggestion.

5. In respect to the method of admission following seat sharing pattern is already in vogue for several years,

In this occasion, while in the process of fixation of fee, though this Committee decided to fix the Fee separately for each College, on going through the Proposals submitted by the Colleges along with the expenditure statements, it seems that the expenditure shown in the proposals includes the expenditure incurred by the hospital which is run by the institution separately. Hence the Committee send communication to the colleges dated 27.05.2025 requesting them to send the expenditure statement separately for College and Hospital. In response to the letter sent by the Committee,

some of the institutions send a reply that the expenditure cannot be separated for college and hospital. So in the said circumstances it is not probable to take the entire expenditure statement submitted by the colleges for fixation of fee, also it is quite difficult to segregate the actual expenditure spend by the college. In this regard the Association members along with the representatives of the Colleges who are all appeared before the Committee on 12.06.2025 requested the committee to fix the common fees for all the member colleges of the Association and submitted the request letter to that effect.

7. Secondly as far as the method of admission is concerned the students who are all eligible for getting seat in the medical colleges are admitted under 3 categories namely Government Quota, Management Quota and NRI Quota. Hence the committee decided to fix the fee only on the above three categories alone.
8. The Committee discussed in detail and considered the following:-
  - i. Based on NMC Standards and Norms.
  - ii. The Expenditure details submitted by the colleges in their proposals under various heads referred 3 of our Order.
  - iii. The opinion of the Auditor and the Members of the Committee.
  - iv. Request submitted by the representative of colleges and Associations.
  - v. Seat sharing for admission of the students in Self Financing Medical Colleges.
9. The Committee has considered the judgment of the Hon'ble Supreme Court of India reported in **2022 LiveLaw (SC) 501 in the case of Rashtreeya Sikshana Samithi Trust etc., Vs. Committee for Fixation of Fee Structure of Private Professional Colleges and others ets., wherein while fixing fee, the fee Fixation Committees of the States should take into account all the components of fee, leaving no scope for**

*managements to charge any additional amounts apart from what has been prescribed by the fee fixation Committee from time to time. In the event that the management intends to charge additional amounts over and above the price band fixed by the Fee Fixation Committee, or for any component not included in the structure fixed by the Fee Fixation Committee, the same can only be done with the concurrence of the Fee Fixation Committee*

**ORDER:-**

1. The Committee fixed the following fees noted against the respective colleges all including Tuition fee, Admission fee, Special fee, Laboratory / Computer / Internet fee, Library fee, Sports fee, Maintenance and Amenities fee, extracurricular activities fee, and other recurring expenditure.

2. For the Institution comes under the State Private University, it is true that the expenditure met out by such college is higher than the expenditure met out by the private self-financing colleges who are all affiliated with the State Government University. However documents shows that those following four colleges comes under the state private university are all established recently in the years during

2022 to 2024 and the fee has also been fixed during the same period. Hence on considering the same Committee has unanimously decided that except NRI quota the fee hike for those colleges pertains to UG and PG Medical Courses is not necessary at present. Hence as per the discussions stated supra the following fees has been fixed for those colleges comes under State Private University

Later the Committee discussed in detail with regard to the fee proposals submitted by the colleges for fixation of fee to the Post Graduate medical courses by following the process stated in earlier and ultimately the Committee unanimously resolved to fix the fee for PG Medical Courses as under.

3. The maximum fee structure prescribed will take effect for the students admitted for the academic years 2025 -2026, 2026 -2027 and 2027 -2028.
4. In addition to the above fees, the institution is permitted to collect an amount of Rs.60,000/- per student as development fee.
5. The management is directed to cover all the Students under Students Group Insurance Scheme.
6. The above fee does not include Hostel, Transport, and Mess charges which is optional for the students. The institutions are directed to submit the details of the above fee to the Selection Committee well in advance before commencement of counseling.
7. The Committee directs that the institution shall not collect or levy any other recurring or non-recurring fee including capitation fee.

8. Any deviation from this order, the Committee will send a recommendation to the authority concerned to withdrawal of approval by NMC and disaffiliation by the concerned University as well as imposition of fine.
